Bakers Pond. N 45.34306 W 121.32312. Bakers Pond is located off of Friend Rd, near the intersection of Forest Rd. 27, about 13 miles South West of Dufur, in Wasco County.

Hwy 203 Pond: From Interstate 84, use exit 298, turn East on OR Hwy 203, turn right on West Airport Rd., turn left into the parking lot at Hwy 203 Pond.

Bakers Pond: From US 197, just South of Dufur, turn right onto Dufur Gap Rd. travel about 2 miles. Turn right onto Friend Rd., travel about 10 miles. Turn left onto an unnamed road on the White River Wildlife Area, travel 1/8 mile to Bakers Pond.

HWY 203 Pond: Install a parking lot with ADA parking, ADA accessible cantilevered fishing platforms, ADA bathrooms, lakeside access trails, Kayak launch paved ADA walkways, boulder clusters, bi-lingual informational kiosks, and picnic tables.

Bakers Pond: Install ADA parking, ADA accessible fishing platform, lakeside access path improvements, picnic tables, and kiosks.

### *Overall Project Goals*

*Describe the primary goals or outcomes of the entire project, including elements not requesting funding from R&E.*

The goal of the HWY 203 project is to provide new ADA fishing platforms, a kayak launch, improved parking, ADA bathrooms, picnic & family areas, and bi-lingual kiosks, and access paths. The site will also have a new archery range paid for by other funds from ODFW's I&E department.

The goal of the Baker's pond project is to enhance the site to accommodate ADA and mobility impaired anglers, adding an improved parking area which includes an ADA parking pad, install an ADA accessible fishing platform, lakeside boulder clusters, gravel pathways, picnic tables, benches, and bi-lingual kiosks.

### *Primary objectives of R&E funding*

*Please describe the measurable objectives for the R&E portion of the funding request.*

The objectives of this bundle project are to enhance ADA and family fishing access at two sites located in areas of the state that do not have a high number of ADA accessible fishing locations.

### *Current Situation/Justification*

*Please describe the current situation and explain why this funding is needed.*

HWY 203 Pond. Currently there is limited access at this site, the road to the site is an unimproved two track dirt road that is full of potholes and at times can be difficult to traverse for cars with low clearance. The parking at the site is also un-improved, with no ADA parking areas. Lakeside access is not ADA compliant, the banks are steep, and there are no paved trails or fishing docks. There are no bathrooms at the location, and there has been a history of problems with human waste at this location.

Bakers Pond: This is a spring fed pond located on the White River Wildlife Area in Wasco County, and it is a popular fishing location for local residents and for individuals and families visiting the Wildlife Area. The pond is located in a rural area, but it sees a high rate of use. The access road to the pond is very rough, and like the HWY 203 project, there are no ADA amenities at the pond. The banks of the lake are steep and often very slippery which makes it difficult to fish from the bank, especially for mobility impaired anglers.

### *Recreation and Commercial Benefit*

Both of these projects will provide needed improvements to rural fisheries that are heavily used by local residents and by people visiting from out of town. Use at each location is high, but it is expected that the rate of use is higher at Hwy 203 Pond simply due to its proximity to I-84 and the larger population of Baker City. ODFW stocks both Hwy 203 Pond and Bakers Pond with legal and trophy size trout, along with some larger brood size trout at least once per season, and catch rates are high at each location. Reports indicate that angler satisfaction is adequate at each location, but there is a need for access improvements for ADA and mobility impaired anglers, along with a strong desire for restrooms at Hwy 203 pond.

## ***Internal Review Results***

### ***Summary of Review Team Comments***

The IRT recognized these locations as high use areas and as priorities for developing better access.

### ***Specific Review Team Questions***

*Application states that access to the Hwy 203 Pond is difficult due to the road being in poor shape, but there does not appear to be a plan to address the road. The drawing and text address work around the pond. Will the road be improved also?*

Yes, the access roads to both of the projects listed in the bundle will be improved so that all vehicles can access the site easily.

*I don't see mention in the R&E application about the archery area. How is the fishing project tied to the archery area?*

There is a proposal to construct an Archery Range at the Highway 203 pond property, and if it moves forward, it will be built on the same ODFW owned property where the fishing pond is located. That is how the two projects are related, no R&E money will be used to pay for any part of the archery range, and none of the money that is paying for the archery range will be used on the fishing improvements. The reason we attached the letter of support from the I&E Department about the archery range in the application is we wanted the Board to know about the potential that the property will be further developed for outdoor recreation, beyond just the fishing access improvements. If the archery range is built, people visiting the property may overlap their use between the fishing pond and the archery range and we will likely see individuals using the same common areas, such as the parking lot or the bathrooms, but that is the only tie between the two projects. Building the two projects together on one publicly owned piece of property provides benefits to multiple user groups, and makes sense from the property management perspective from ODFW.

*It's unclear where funding would come from to maintain the restrooms and general maintenance of the sites?*

Maintenance of the restrooms and the overall property will be handled by the ODFW District office. R&E funds will not be used for ongoing maintenance.

*Please explain how the components of the grant application are an ODFW priority.*

Improving fishing access at publicly owned properties is a goal of the ODFW strategic plan to increase and diversify public use and enjoyment of Oregon's fish and wildlife resources. Each component of this project aligns with those specific goals of increasing enjoyment of these resources by diverse populations. This project was also selected from a group of projects submitted through an internal, statewide solicitation process that involved each district.
