During weekends and fishing events at the Marina anglers use the current Marina Parking lot, the Day-Use and sports complex parking lots as well as parking along City streets. We consider this dangerous to pedestrians because of the over-crowding and hazardous parking habits by anglers. Funding is needed to provide expanded and designated parking for anglers and car parking for guide service and day use patrons.

The Marine Board will provide final designs that will be used to obtain a contractor to complete the project. The restroom will be ordered from State Price Agreement. All items completed will comply with Marine Board design guidelines for recreational boating facilities and meet current ADA requirements. The District will have administrative oversight of construction and inspections as well as providing force account labor and equipment to clear the existing grass and begin the leveling of the ground using volunteer labor, equipment, materials (fuel) and disposal of existing fencing, curbing, other hardscape/landscape materials and supplying all signage needed for the project.

Internal Review Results

Review Score: 1.4 out of 3

Summary of Review Team Comments

While the review team was generally supportive of access improvements at this site, the application lacked the details necessary for this proposal to be fully evaluated. The team felt they did not have enough details to understand what was being proposed and fully evaluate the proposal. The review team scores included six 1s, and four 2s

Specific Review Team Comments

The application speaks to expanded parking, but a nearly half of funds are for a fish cleaning station, shelter and utilities but there is almost no description, justification, or operations plan provided for that portion of the work. this needs to be added to the application.

If recommended this project should be conditioned upon receipt of other funds.

There is no description of the current facility (other than a brief summary in the OSMB memo) for comparison to the proposal.

While the need for enhanced parking is supported, there is minimal justification included in the application to support why anglers should cover \$70-80k. There are many users of the ramp and OSMB determined the amount of non-boating use and would not cover that cost. Anglers should only be asked to cover an equitable amount and not provide day use spaces for swimming and park users. This needs to be spelled out much better and the amount being requested needs to be clearly justified and tied to angler benefit/use.

Specific Review Team Questions

While the fish cleaning station is a direct benefit to anglers there is no justification for the addition of this station. How much use will it get? How will it be routinely maintained/cleaned. What will happen to the waste? Is there a local company that will accept/dispose of the fish waste?

Although the Fish Cleaning Station would get a lot of use, it has recently come to our attention that the Fish Cleaning Station is not a practical addition to our Marina at this time, and the Park Board will need to further review that portion of the Grant Application. It is the consensus of the majority of our Board that we eliminate that portion of the project.

It has also come to our attention that anglers can legally clean their fish and dump remains into the Columbia River now, so we will be posting that information and hopefully will no longer need the fish cleaning station.

OSMB presented several concepts, please explain why Option A was chosen over the others. The Board of Directors decided upon Option A because it provides pull-in parking for our anglers and if this method works well, we will likely opt to have it the same way in Phase 2 which will be resurfacing our existing parking lot. Option A also provides a greater number of single car parking, which not only helps with day use parking (very small percentage) but also the guide services that operate out of our Marina and their clients. The single car parking that we currently have, is mostly used by the guide service clients and anglers fishing from the banks/jetty. We feel that Option A best utilizes the limited amount of space we have available for expansion.

Please expand on the number of peak use days that result in overflow parking into the community

streets. Is the increased parking sufficient to solve the current offsite parking problems, or is the use high enough that it will remain? How often does the overflow parking occur- regularly, just during peak seasons, weekends? Estimate/survey of current use? How many cars/anglers a day/week/month? What's the nearest similar facility?

From early spring when the water temperature comes up through late fall are our peak times for fishing the Columbia from our Marina. Mondays, Tuesdays, Wednesdays the Marina Parking Lot is usually about half full. Thursdays, Fridays, Saturdays and Sundays the Marina Parking Lot is overflowing. The Proposed Parking would generally cover the overflow parking problems, although there will still be times when the overflow will be used. Peak Season in the Irrigon Marina is during the Walleye Season. Please see the attached article. The photos appear show a lot that is not full and in good shape relative to other facilities in the state. Given the apparently much greater need in so many other places, why should a large portion of our limited budget be used here? What's the truly compelling/urgent need?

On the particular day that the photos were taken, the Marina Parking Lot was full, and all of the photos show the over-flow parking, i.e., the Little League Field, City Street, Day Use and outer edges of the Marina Parking Lot. We have attached photos of the Marina Parking Lot that same day. The truly, compelling urgent need is that we need to have the boaters use the designated areas for safety reasons. When events are happening in the Day Use areas it is extremely dangerous for Boaters to be parking in the Day Use Area, where small children and elderly are moving from the parking area to the park. Please review under "Public Comment" the letter from Bill Duke, ODFW Biologist, Pendleton.

When will the pending funds from the Oregon Marine Board and the Parks and Recreation District be secured?

The Oregon State Marine Board Funds have been awarded and the Park District funds are available. Both will be available when the Notice to Proceed is issued.
