Irrigon Marina is at River Mile 281.9. Street Address: 510 NE Seventh Street, Irrigon, OR 97844. Entrance to the Irrigon Marina Park is at the intersection of NE Tenth and Washington - Travel north on NE Tenth from Hwy. 730 to Park entrance, continue ahead, past day use area and existing restroom, to the Marina boat launch and parking area at far west end of the Park. (Turn right at the entrance for the sports complex and associated lower and upper level parking levels.)

Directions to the site from the nearest highway junction.

Travel on I-84 to Exit 168 to Highway 730/Irrigon (168 miles east of Portland Oregon and 40 miles west of Pendleton). Travel approximately 7.5 miles to Irrigon, then turn North on NE Tenth Street, straight through two 4-Way stops into the Irrigon Marina.

Following project completion, public anglers will be allowed the following level of access to the project site:

Overall Project Goals

Describe the primary goals or outcomes of the entire project, including elements not requesting funding from R&E.

The primary goal of this project is to improve angler opportunities by expanding the parking infrastructure for the boat launch, to include ADA-compliant restrooms, both of which will improve not only access for disabled or elderly anglers, but also the quality of the angling experience for all anglers and boaters.

Phase 2 of the project (not included here) will involve re-surfacing and re-striping the existing launch area parking lot to bring it up to date with current design standards for boat trailer parking.

Upon completion of this project, the angling experience will be improved because of nearby trailer parking and an accessible restroom. In addition, conflicts with other park users will be reduced, emergency access will be maintained, and safety will be improved for both pedestrians and drivers.

Primary objectives of R&E funding

The funding from the R&E program will be used to complete the construction of a new parking lot and ADA-compliant restroom at the Irrigon Marina by the end of June, 2019.

Current Situation/Justification

Please describe the current situation and explain why this funding is needed.

This funding is needed to improve parking and sanitation infrastructure at the heavily used Irrigon Marina Park to enhance angler access and the quality of the angler's experience. When the launch ramp trailer parking area fills, boaters park around the edges. As the edges fill, boaters then start parking in the lower (southern) portion of the next lot to the east, which is intended for the day users of the park, but has a few "overflow" boat trailer parking spaces along the southern edge. When the overflow parking becomes full, boaters are forced use city streets adjacent to the park or the graveled parking lot of the sporting complex to the east of the park entrance (almost 1000 feet away from the ramp), or, unfortunately, boaters choose to park across multiple single vehicle spaces. Although the District maintains a portable toilet at the launch ramp, the nearest restroom is over 550 feet away from the ramp (OSMB recommends sanitation facilities be located within 200 feet, with a maximum distance of 400 feet). The ODFW Umatilla District Fish Biologist (see letter in Public Comments) notes that the Irrigon Marina Park "provides angler's access to the Columbia River's salmon, steelhead, walleye, bass and sturgeon populations." He expresses ODFW's support for the project stating that "The boat ramp was replaced in 2015, and since completion use of the new ramp has consistently exceeded the existing parking facilities. [This project] will allow for better traffic flow and provide the additional parking space needed to better handle the use at this popular boat ramp."

OSMB states that "The parking lot configuration was designed when the facility was built circa late 1960s-early 1970s. The parking stalls are short (38-feet) for the size of many tow vehicles and boat trailers that currently use the facility. As a result of longer vehicles with trailers, they extend into the travel lanes making it difficult to use the parking area." The OSMB concluded that "the development of additional parking will improve boater safety and relieve congestion...," and observed that with the current restroom more than 550 feet away from the ramp, "installing a two-stall restroom near the boat ramp will be a welcomed relief for boaters" (see OSMB Grant Description).

Please describe in detail the methods or approach that will be used to achieve the project objectives. We have worked with the Marine Board to develop conceptual designs for the project. The Marine Board will provide final designs that will be used to obtain a contractor to complete the project. The restroom will be ordered from State Price Agreement. All items completed will comply with Marine Board design guidelines for recreational boating facilities and meet current ADA requirements. The District will have administrative oversight of construction and inspections as well as providing force account labor and equipment to clear the existing grass and begin the leveling of the ground using volunteer labor, equipment, materials (fuel) and disposal of existing fencing, curbing, other hardscape/landscape materials and supplying all signage needed for the project.

The project has a 20-25 year useful life span with ordinary and routine maintenance. Routine maintenance consists of cleaning/stocking the restroom, inspecting the building. Restriping the

parking area, occasional crack sealing. Inspect all aspects regularly and make repairs as necessary.

Who is responsible for long term management, maintenance, and oversight of the project beyond what is funded by R&E.

The Park District has managed the Marina for decades and anticipate continuing to do so. The District will maintain and pay for all necessary repairs, updating and replacement of equipment associated with this project through annually budgeted maintenance funds.

Will the project require ongoing maintenance?

Yes
