This project will replace an inaccessible toilet with a double stall vault toilet, paved ADA parking, and fishing/boating educational signage that will be posted on the restroom building at the south side of Morgan Lake where most anglers enter.

Install a double stall vault toilet that includes educational signage on the south side of Morgan Lake near the entry sign along with paved ADA parking to serve anglers and other users on the south side by October 31, 2021.

#### Current Situation/Justification

Please describe the current situation and explain why this funding is needed.

Morgan Lake is primarily a fishing area with a campground at the north end. On the south end there are several small fishing docks that are heavily used. What makes this so popular is it's 2-mile proximity to La Grande. Currently there is an old deteriorating vault toilet located on the southwest end of the lake, but it is inaccessible for persons with disabilities and hidden in the trees. The only other toilet is located about ¾ mile from the south entrance on the north side of the lake near the main boat launch. If anglers are using the fishing docks on the south end of the lake, they are forced to "go" in the woods or travel to the north end. Every summer, there is human waste and toilet paper strewn throughout the south end of the lake visible from the main hiking trail that inhibits the enjoyment of all users. There are no educational signs at the lake. Funding is needed to install the new restroom along with educational signage that will be placed near the main entry road so it's easily accessible, especially with the addition of paved ADA parking.

#### Project Design and Description

Please describe in detail the methods or approach that will be used to achieve the project objectives. The vault toilet building is a pre-engineered, pre-fabricated, two stall building with chase that will be purchased from CXT (low bid). We plan to order the Tioga model specifically and since we are in zone 3, the price quote was \$32,476. I have attached the confirmation email from the vendor in the supporting documents. Note that we have rented porta potties for this location before and they were heavily used. At times, it was a challenge for the company to get their trucks up the steep grade to the park making it cost prohibitive. A longer term solution is necessary.

Site prep work equipment and labor will be provided internally by the City of La Grande's Public Works Operators and Parks Leadperson. After the site is prepared, CXT will coordinate the actual installation of the building on site. Finally, a local contractor will pave the ADA parking stall and connector sidewalk to the newly installed restroom building. The concrete pad will be approximately 17 x 21 feet and will be the starting point for a future paved connector pathway down the hill behind the new restroom to the fishing platforms and day use area below. I have attached the contractor's estimate in the supporting documents and although it may sound expensive, the terrain at Morgan Lake is exceptionally rugged and rocky. Any site work is a challenge at this location.

R&E funds will be used to help purchase the restroom building, pay for signage, and pay for the paved parking stall. We would like to work with ODFW to select appropriate signage that will be attached to the building. Other grants will be sought to support the project including funding from the Marine Board and Wildhorse Foundation. City General Fund dollars will also be used to supplement contingencies.

#### Summary of Review Team Comments

The review team is supportive of the proposal but requested additional information to fully justify and explain the proposed work. Scores included one 3, eight 2s, and one 1.

#### Specific Review Team Comments

Good non-ODFW project that will improve the angling experience. Proportion of R&E funding seems commensurate with likely angler benefit.

While this will benefit more than just anglers, reduction in human waste issues should improve conditions for anglers.

It would be good if ODFW were able to review and influence the educational signage to ensure consistent messaging, accuracy and adequate content. ODFW has existing fishing related signage and information available.

Please update the project description to provide a few more details on the project and alternatives.

- o Since this is so close to La Grande, was use of a porta-potty investigated as a more appropriate or cost-effective option? Were other alternatives explored to reduce costs?
- o Since this current proposal will not be directly connected to any existing or proposed ADA or other facilities, what are the future plans for site development including ADA pathways or fishing platforms? How well is the proposed location of the parking a restroom suited to logically and efficiently connect with future development?
- o Please provide more details on the work being performed with the \$10,000 in the budget for concrete contractor. This seems high for parking, connecting sidewalk and restroom apron.
- o Please explain, or provide a completed quote for vault toilet. The attachment does not have any of the options selected or total identified.

#### Specific Review Team Questions

Please better describe the angling use at this late and how much angling vs. non-angling will occur at the location of this restroom/project? Does ODFW stock this Lake? What species of fish are in the lake? What is the angler use at the lake?

Morgan Lake has been used by anglers for decades and the City has a strong relationship with ODFW to stock the lake twice per year. It opens based on ODFW regulations on April 22nd and traditionally is stocked the week before opening day and again during the summer. The Optimist Club holds an annual kids fishing derby on or around opening day and the excitement continues through the summer with hundreds of anglers fishing per month. There is also a campground with 12 spaces spread out on the north side along with day use picnickers and boaters. Species present in order of abundance according to 2019 ODFW Data. Relative abundance in parentheses - Rainbow trout (12 fish/net set), Largemouth Bass (3.5 fish/net set), Brown Bullhead (3.5 fish/net set), Crappie (1 fish/net set), Smallmouth Bass (Recorded as present, abundance data NA)


