Project Summary

This project is part of ODFW's 25 Year Angling Plan.

Activity Type: Access

Summary: The applicant will improve access to the Little Deschutes River, near La

Pine, on three properties owned by the the State of Oregon. In the area between Sunriver and Gilchrist, the Little Deschutes River has limited public parking, boat ramps, and developed access points. The river is used by anglers and and other boaters, but only in limited areas. The project will add parking, three boat ramps (with fish habitat and erosion reduction structures), demarcated property boundaries, improved trails, and signage, at the three properties. The project will improve the opportunity to fish and

recreate on the Little Deschutes River.

Objectives: On the Little Deschutes River, the project objectives are: 1) improve boat

access, 2) enhance existing foot paths, 3) survey property boundaries, 4) add signage, 5)add parking areas, 6) prevent trespassing, and 7) prevent

erosion.

Fishery Benefits:

Anglers will benefit from this project because of three new ramps to launch boats to access the fishery in the Little Deschutes River. New parking will enhance one of the public properties. By adding signage, ODFW will attract anglers to the three properties and approximately 5,000 feet of river frontage. This river is open to the use of bait and is also a very good fly and spinner fishing river because of the slow flows. Anglers can fish for rainbow trout, brown trout, brook trout, mountain whitefish and crayfish. Signage will also prevent trespassing onto neighboring properties.

Watershed Benefits:

The benefit to the watershed is to provide another place where people can recreate and appreciate the Little Deschutes River and its fisheries near Sunriver, La Pine and the surrounding communities. When people attempt to launch boats, the new boat ramps sites will reduce climbing on exposed stream banks and the resulting erosion. The ODFW fish habitat biologist will assist in the design of boat ramps to: 1) minimize bank disturbance, 2) prevent future erosion, and 3)using bioengineered structures, create fish habitat. Additionally, an eroding bank at one of the properties will be stabilized using bioengineering. Downed wood that is blocking footpaths and planted willow will be used to create bank stability and fish habitat.

Current Situation:

At the three ODFW owned properties on the Little Deschutes River, there are: 1) eroding banks where people launch boats or angle from the bank, 2) no signage denoting access to public property or property boaundaries, 3)poor footpaths, and 4) limited parking.

Alternatives:

No project alternative was considered. This project will improve on the exsting condition. Nevertheless, if some part of the proposed project was omitted, any other part would be an improvement over the current condition.

Designer:

ODFW staff will design and build the project. There will be input from the district fish and wildlife biologists and our stream restoration biologist.

Methods:

The project will be designed, and permits will be acquired. A 4WD backhoe will be rented and operated by ODFW staff. Eight foot wide boat ramps will be constructed, with the backhoe and the sites will be stabilized using bioengineering techniques with locally obtained materials. Gravel and bark will be purchased and delivered to each property. Volunteers and the backhoe will be used to spread gravel and bark and to create parking at one property.

Kurt Cundiff and Randy Lewis will work with volunteer groups to coordinate clean up projects, build trails and post the properties.

Jack Williamson (Stream Restoration Biologist) will acquire fill-removal permits, and design the boat ramps and bioengineering structures, and oversee construction.

Jen Luke(STEP Biologist) will coordinate STEP volunteers.

Brett Hodgson and Ted Wise (Fish Biologists) will oversee designs. Steve George and Corey Heath (Wildlife Biologists) will oversee designs.

EXPLORE OREGON - This is a group from Portland that has kids from all over the state who go out on a two week trip to help with community projects. They will bring 20 kids out to help with some clean up and trail building on the sites.

JUVENILE COMMUNITY JUSTICE - This is what it sounds like. We can get a group of kids (16) out to this site once a month to spend the day doing clean up, trail maintenance, and building things to pay their community back.

Mule Deer Foundation - This non-profit will contribute two hundred dollars to help out the community and some time placing posts with signs on them marking the property lines.
