Project Summary

This project is part of ODFW's 25 Year Angling Plan.

Activity Type: Summary:	Access This project seeks to improve a boat access site on the Nestucca River. A concrete retaining wall will be installed to protect the road edge, and a wooden slide will be installed to allow boats access to the river.
Objectives:	The objectives of this project are:
	 Improve boat access to the Nestucca River at the Borba Rd. launch site. Reduce or eliminate erosion and deterioration of the road edge and river bank. Reduce traffic congestion and conflicts caused by boat launching from the road. Improve boat trailer turnaround and parking to reduce conflicts with neighboring landowners.
Fishery Benefits:	This project would benefit recreational anglers by improving boat access to the Nestucca River. This launch site is important because it is one of the most upstream launches available, and is the first one below a hazardous rapid/bedrock chute that many boaters wish to avoid. The site is near a hatchery steelhead release site, and receives a substantial amount of use by drift boat anglers.
Watershed Benefits:	This project seeks to improve access at one boat launch site, and therefore does not have benefits at the watershed scale. However, this project should result in reduced bank erosion at this site, which could lead to reduced sediment input to the system, albeit on a minor scale in relation to the entire basin.
Current Situation:	As used in its current state, boaters must pull up to the launch site on Borba Rd. After stopping in the road, boats are dropped off the trailer onto the roadway. Boats are then swiveled perpendicular to the road, and pushed over the edge. Boats are then slid down the exposed bank to the water. Anglers then climb down the dirt bank to the river. Vehicles proceed up the road to turn around (sometimes utilizing private driveways) and return to the site to park (often without being able to park completely off the road). This process can create traffic congestion, and certainly damages the road edge and river bank with repeated launchings over time (see attached photos). Previous roadside repairs done by Tillamook County Road Department have only served to cause boaters to launch a few feet down the road, and the process of road and bank damage begins again.
Alternatives:	One alternative is to seek an alternate launch site. However, all of the land upstream of the current site up to the hazardous rapid/bedrock chute is privately owned, and there has been no interest in a sale or easement by local landowners. Downstream of the current site the road moves higher above the river and the bank becomes steeper, and thus there is no suitable alternative site in the vicinity.

	The other alternative is to leave the launch in its current state. Road and bank damage will continue to occur, and eventually the County would have to conduct additional repairs that will likely not be boater friendly. The worst case scenario is that boat launching could eventually be precluded at this site, either by physical barriers (road repairs) or ordinance.
Designer:	ODFW and Tillamook County Road Department
Methods:	1. A concrete retaining wall (approximately 40' long by 3' wide by 3' deep) will be installed along the road edge. The wall will be slotted in one section to accomodate the top of the boat slide while maintaining a level surface along the road edge.
	2. Two concrete supports (approximately 6' long by 2' wide, and of sufficient height to match the slope of the bank) will be placed down the bank. Pressure treated wood planks will be secured to the supports and in the slot on the retaining wall to provide the sliding surface for boats.
	3. Formed concrete steps will be poured alongside the boat slide for access down the slope. The exact location of the steps (upsteam or downstream side) is yet to be determined.
	4. Accumulated road side dirt will be rmoved and hauled away. A turn around area 1/4 mile upstream will be expanded by excavating a berm and removing additonal material along the road shoulder. Signs will be posted marking the turnaround and advising boaters about parking issues.


