Addition of a pit toilet similar to the ones at the other local parks would improve sanitary conditions at this heavily used ramp. Addition of picnic tables will improve the park utility. No other source of funding has been available.

A standard pit toilet will be added in the parking area about 30 feet above the riverbed which can be serviced by pump-out from the parking lot. Details of the CXT toilet are contained in later section of this proposal.

Expect that the pit toilet will remain in service for at least 30 years with minimal maintenance required. Picnic tables proposed are pre-cast concrete and should remain in service for at least 30 years. Trails will require maintenance every few years by the City of Siletz.

City of Siletz Parks and Recreation Department—City of Siletz services other city park toilets with pump-out on a scheduled basis and will add this location to their routine.

Internal Review Results

Review Score: 0.1 out of 3

Summary of Review Team Comments

While the team is supportive of improving access facilities, the review team was not supportive of this proposal as written. This project and 17-010 should be combined and funded primarily by other funding sources and overall project development should be coordinate with or through the technical resources at the Marine Board. The team felt RE would be more appropriate as match for these other funding sources. Scores were eight 0s and one 1.

Specific Review Team Comments

While access is supported, RE should not be paying for this exclusively.

These upland improvements would be more appropriate for another funding source such as state parks or marine board with some RE funding as match.

Marine Board has been involved but then due to local political issues it appears the applicant is pursuing RE funding.

The site is relatively small and may not be appropriate for continued investments. This project needs to be looked at, or explained, in a larger perspective, not just "fix what we have" as a new large site may be more appropriate.

Picnic tables, while nice, probably shouldn't be funded by angler dollars.

Some elements of the application are overstated.

No match from the city/county. This is their park and they should contribute some funds if repairs are needed.

Combine this and the next project as a package for Marine Board funding if appropriate

There is no cost share or investment coming from the city or county. If this is a necessary development that will be maintained by them, they need to have some level of ownership in the upgrades.

Application states "minimal maintenance" will be needed. This is not a realistic assessment. Restrooms and tables will need maintenance and repairs to ensure the survive a reasonable life span and remain in useable condition.

Engineering is needed to ensure long term success of this project, especially to ensure ADA compliance, permitting, and local codes are met.


