The ramp was installed by Wasco County in 1968. After 42 yrs. of use it was condemmed and blocked off by the County. The County recommended that the local residents form the SWPRD; which is applying for this grant to re-open the North boat ramp.

The project which was laid out by the OSMB will include removal of a dangerous broken ramp, rebuilding the ramp, stormwater control and maneuvering improvement to provide increased fishing access.

Primary objectives of R&E funding

Please describe the measurable objectives for the R&E portion of the funding request.

The ODFW R & E grant of a conceptual cost estimate of \$161,100 as prepared by the Oregon State Marine Board to repair the North Boat Ramp.

Current Situation/Justification

Please describe the current situation and explain why this funding is needed.

Several groups have attempted to address the ramp problem and failed. The South Wasco Park & Recreation Dist (a non taxing entity) has reached out to the community (including a survey by Oregon Kitchen Table) with an overwhelming positive result. We are making several attemps to find funding for this project. We have asked local busnesses and residents for help, placed a donation box at the south boat ramp and started a GO-FUND-ME site. At this point, we have received donations totalling approximately \$6,000.00. We have an agreement with Badger Irrigation District and Wasco County to remove and replace the ramp in two years time. The land will revert back to Wasco County and the lease with Badger Irrigation District will terminate at the end of 2019 if we are unsuccessful in our attempt to finance the ranp's replacement. In an attempt to keep the project going, we hired a local construction company to remove the broken concrete.

Pine Hollow Reservoir is year round fishing and ranks 38th out 199 in Oregon boat use days. The public campground adjacent to the north ramp and other local businesses have complained about revenue loss due to the closed ramp. Getting the north ramp repaired will greatly improve access to the reservoir and take pressure off of the south boat ramp which is also failing. The Oregon Marine Board is working with us to secure a grant to repair the south boat rammp. They have agreed to provide engineering and cost estimates on both ramps.

Internal Review Results

Review Score: 2 out of 3

Summary of Review Team Comments

The review team was supportive of this project. The application does not adequately tell the story of why RE is being asked to pay for most of the north ramp or how this fits with other funding sources and work. However, the project is necessary and worthwhile to protect access for anglers in an important reservoir that ODFW pays \$14,000 per year to maintain water levels for fishing use. Scores included all 2s.

Specific Review Team Comments

This was previously approved at \$95k but due to lack of county backing OSMB is now unable to fund the remaining portion of the north ramp. However, OSMB is able to, and has, commit to repairing the south ramp and will continue to pursue upland upgrades at the north ramp once the parks district is able to prove up their ability to maintain the facilities. Park district is also pursuing OPRD funding for some upland facilities.

Please describe or identify the units better in the budget, especially the \$14,500 for mobilization.

This proposal is supported by many, including ODFW. Project provides access to a valuable regional fishery. OSMB involvement to provide assurance that permits and clearances are obtained is important.

Specific Review Team Questions

In the application, please provided more context and information on how this proposal fits as a package with the OSMB funded improvements at the south ramp and State Parks funding for restrooms and upland infrastructure. including, why is RE being asked to pay for the North Ramp, how is OSMB involved with the north ramp, how does the OSMB work at the south ramp relate to this, what other funding/facilities are you pursuing for the north ramp area?

The removal and replacement of the north boat ramp at Pine Hollow Reservoir was originally planned in 2017 as a project that was to be jointly funded by grants from ODFW and the Oregon State Marine Board (OSMB), supplemented with funds that South Wasco Park and Recreation District (SWPRD) would provide.

SWPRD applied for, and was conditionally granted, an approximately \$94,000 grant from ODFW on the condition that OSMB be involved in the project to provide design and regulatory oversight.

The OSMB board became concerned about SWPRD's long term viability because of the fact that SWPRD is a non-taxing special district, and because SWPRD had only been in existence for little more than a year. Because of these concerns, the OSMB board insisted that SWPRD provide a 20 year "guarantee" from another entity. Said guarantee would insure that required maintenance would be completed, and that the facility would not be converted to private use.

The only entity available to SWPRD to provide the requested guarantee was Wasco County Government. The Wasco County Commissioners were only able to commit to provide a 10 year guarantee.

A 10 year guarantee was not acceptable to OSMB so the project was not funded by OSMB and, therefore, ODFW was unwilling to fund their grant because SWPRD could no longer provide OSMB oversight.

OSMB staff visited the Pine Hollow Reservoir in August of 2017 and came to the conclusion that the south boat ramp was in imminent danger of failing too. Because of this, OSMB management came up with a plan whereby OSMB would design and fund the repairs to the south boat ramp, and would accept Wasco County's 10 year guarantee as adequate at this location. OSMB offered this because they determined that, even with the proposed repairs, the south boat ramp only had about a 10 year remaining life, which is consistent with the guarantee that Wasco County was offering, and because proper boat trailer parking and restroom facilities already exist at the south boat ramp.

OSMB management staff, working with ODFW management, also proposed that ODFW fund the entire scaled down project of removing and replacing the failed north boat ramp at Pine Hollow. OSMB offered to provide design and insure regulatory compliance for the north boat ramp reconstruction project in addition to their proposed work at the south boat ramp. The north boat ramp project is scaled down in that it no longer contains parking improvements or a new restroom.

SWPRD is currently in the process of applying for a grant from the Oregon Parks & Recreation Department (OPRD) to install a two-stall precast vault toilet restroom at land we own adjacent to the north boat ramp. That grant application is due to be submitted to OPRD on May 1, 2018.

SWPRD had the old, failed, north boat ramp removed in November of 2017, therefore the removal of the old ramp is no longer within the scope of the project.

All of the construction funding estimated dollars that are included in our grant application come directly from OSMB's preliminary project budget estimate.

We agree that many of the costs appear to be high but, since the project has not been finally designed, nor have any bids been solicited, we have no other tools available to estimate project costs.

In discussing the OSMB cost estimate with OSMB management staff, they agree that their estimate is "conservative" and that, should we be able to secure local contractors to do most of the work, we may be able to complete the project for significantly less money.

Obviously, any realized savings would accrue to ODFW and, because our project should be completed early in this funding cycle, those funds could be used by ODFW to fund additional projects elsewhere in the State.

On Wednesday, April 18, 2018, in Salem, Oregon, the OSMB Board approved our grant application for the south boat ramp repairs.


specific information on things like number of launches per day (north and south), problems caused at the other ramp by not having this one in use, and if applicable, how much non-angler use is there and is it contributing to the problem.

That information came from a CSV file downloaded from the Marine Board. Recently we came across a more current file from the Marine Board (http://data.oregon.gov/recreation/waterbodies-in-rank-order/rqyv-cfng) which ranked Pine Hollow as 40th out of 209 water bodies. The most recent document lists the following information for Pine Hollow: Days-15,764; Trips-11,902; Activity Days-14,335; Fishing-13,099; Water Skiing-1,153; Cruising-84. Fishing accounts for 91% of all uses at this reservoir. There is no data available regarding number of launches at either of the boat ramps. Since the north ramp has been closed for about 7 years, all launching has been occurring at the south ramp. At times in the warmer months the south ramp gets rather chaotic due to sub-standard design and heavy use. It is not uncommon to see long lines and conflicts between users.

What permitting has been identified and what is the status of permit review?

The proposed boat ramp is located in a flood zone and will therefore require a land use permit from Wasco County. A building permit will also be required, along with review by the Oregon Division of State Lands and the Army Corps of Engineers. None of these permits have been applied for yet for three reasons: First, we need to have final design drawings for the work. The Marine Board will provide engineering design for the north ramp even though the Marine Board is not providing funding for this project, assuming that ODFW participates. Second, the Marine Board offers to provide help in applying for and securing necessary permits. They will not provide that permitting help until ODFW grants funding. Third, permits are expensive and require significant labor to complete. It does not make sense for us to risk that money and effort because we cannot proceed with this project without ODFW funding and Marine Board design assistance.
